

## Contest Terms & Conditions

### 1. Organizer

- 1.1. The **“SHOP AT WATSONS & WIN PRIZES FROM XIAOMI”** is organised by Watson’s Personal Care Stores Sdn Bhd (“the Organiser”/ “Watsons”).

### 2. The Campaign Period

## 5.3. Winner selection logic
